Mountain NAR.

The California bighorn sheep (BHS) herd on Hart Mountain National Antelope Refuge in southeastern Oregon declined from ~150 animals in 2017 to as few as 48 in 2020. Consequently, this BHS herd is at risk of extirpation without prompt management intervention to restore the herd to a sustainable level. In 2022, the Hart Mountain BHS Management Plan & EIS was developed to identify management actions to aid in the recovery of the herd. The California BHS, an iconic species native to Oregon and the Refuge, was extirpated from the state by 1912. The species was successfully reintroduced in 1954 when 20 BHS were translocated to the Refuge. After reintroduction, the Refuge herd was robust enough to be used as a source for translocating BHS to other areas in and around Oregon. Action is needed to address rapidly declining BHS numbers that place the herd in significant risk of extirpation from the Refuge in the next few years. An integrated management approach focusing on short-term predator control (mountain lions) and long-term habitat management actions (juniper control and water sources) are specifically targeted to benefit and recover BHS and support a sustainable herd. This funding request will focus on specific recovery actions supporting short-term mountain lion control.

If approved, Oregon Wildlife Foundation funds would be applied to an agreement between USFWS-Hart Mountain NAR and USDA-APHIS-Wildlife Services to conduct professional cougar control within the Bighorn Sheep-Cougar Management Zone on Hart
